## REQUIREMENT 1 (INITIAL ONE):

\_\_\_\_\_ I am a graduate of an Arkansas public or private high school

\_\_\_\_\_ I have earned an Arkansas high school equivalency  
Submit your official high school transcript or GED scores to the UACCM Admissions Office if you have not already.

## REQUIREMENT 2 (INITIAL):

\_\_\_\_\_ I have resided in the State of Arkansas for at least three (3) years at the time of application for admission.

### SUBMIT ONE OR MORE OF THE FOLLOWING WITH THIS FORM:

- Official high school transcript from an Arkansas public or private institution indicating continuous enrollment at the institution for three (3) years previous to the date of application for admission.  
 Check this box if you have already submitted this documentation to the UACCM Admissions Office.
- Billing history indicating in state residence for at least three (3) years previous to the date of application for admission.
- Driver's license or state identification card issued in the State of Arkansas at least three (3) years previous to the date of application for admission.
- Notarized letter from an employer or landlord verifying Arkansas residency status for at least three (3) years previous to the date of application for admission.

Other forms of verification may be accepted at the discretion of the institution.

## REQUIREMENT 3 (INITIAL ONE):

\_\_\_\_\_ I hold a Federal Form I-766 United States Citizenship and Immigration Services issued Employment Authorization Document, known as a work permit.  
Submit with this form your unexpired Employment Authorization Card

\_\_\_\_\_ My parent holds a Federal Form I-766 United States Citizenship and Immigration Services issued Employment Authorization Document, known as a work permit.  
Submit with this form an unexpired Employment Authorization Card issued to your parent and documentation, such as birth certificate, verifying the parent-child relationship.

\_\_\_\_\_ I have requested and been approved for an exemption under Deferred Action for Childhood Arrivals. Exemption must be current.  
Submit with this form a copy of your Form I-797, Notice of Action which specifies Case Type: Consideration of Deferred Action for Childhood Arrivals and Notice Type: Approval Notice which has not expired.

\_\_\_\_\_ I have immigrated from the Republic of the Marshall Islands and has verified legal presence in the State of Arkansas.  
Submit with this form a copy of your passport, Employment Authorization Document Card, Permanent Resident Card, or Unexpired Immigrant Visa. Additional forms of verification may be accepted at the discretion of the institution.

I (the student) understand that I must submit verifying documents prior to census date of the semester enrolled to receive in-state tuition (typically the 11th day of classes). If verifying documents are received following census date, my tuition status will be changed for the next semester in which I enroll, if all documents remain valid. I understand that it is my responsibility to submit current documents (not expired) to the UACCM Registrar's Office to continue to receive in-state tuition in future semesters.
